## ACCESS 67



- HB 1239: Broadband Internet Infrastructure by Representative Tomkow
  - Signed by Governor on May 7<sup>th</sup>
- The legislation adopted provisions from several broadband bills to create a multifaceted approach to addressing the Digital Divide in Florida.
  - FAC supported provisions include:
    - broadband mapping improvements including funding to address the discrepancies in access maps reported speeds
    - Additional requirements for local technology planning teams (coordination w/ DEO Office of Broadband)
  - HB 753 (Rep. Clemons): contained provisions for the "Opportunity Grant" program
    - Funding program to expand access. This session the Legislature did not provide funding for the grant program in hopes of further developing the requirements for applicants.
  - Telecom access to municipal electric utility poles (rates/access)



## ACCESS 67



- Broadband Bills that FAILED:
  - SB 2004—Broadband Internet by Senator Burgess
    - Provisions bolstering the Office of Broadband were absorbed into HB 1239; however, the funding for a feasibility study was not included in the budget.
    - Feasibility study would allow state to draw down additional federal funds
  - SB 1560—Broadband Internet Service by Senator Ausley
    - FAC Supported; cleared all committees favorably
    - The mapping components of the bill were incorporated into the "broadband package"
    - Provisions left out of "broadband package"
      - Broadband Deployment Task Force
      - State Asset map
      - Individual benefit program



## FCC Fixed Broadband Deployment Florida Mapping




25Mbps down/3Mbps up


25Mbps down/3Mbps up (w/out Sat.)



## FCC Fixed Broadband Deployment Florida Mapping




25Mbps down/3Mbps up


100Mbps down/10Mbps up

## American Rescue Plan



#### Broadband Infrastructure

- Focus on households and businesses without a wireline connection capable of reliably delivering 25 Mbps download/ 3 Mbps upload
- Fund projects that deliver reliable/"symmetrical" service (minimum 100 Mbps download/100 Mbps upload speeds unless impracticable)
- Complement broadband investments made through the separate Capital Projects Fund

### • Eligible Projects

- Does not require every home/business to be unserved or underserved
- Holistic approach to provide service to wider area; to make service area "economical"
- "middle mile" projects allowed BUT encourages last-mile connections
